

General terms & conditions for promotions and competitions

These general conditions for promotions and competitions (hereinafter the "Terms and Conditions Competitions") apply to competitions and other promotional activities organized by Rotaid AED Cabinets and/or its subsidiaries or its affiliated companies (hereinafter "Provider"). By participating in the Provider's competitions, the participant agrees to the following Terms and Conditions Competitions. In addition, each competition and/or other promotion also has specific terms and conditions mentioned in the specific competition rules.

1. Campaign period: between 9:00 CET on May 16, 2018 and 23:59 CET on June 30, 2018. During this promotional period there will be one winner.
2. The competition is open to any person over 18 years of age except employees, or family member of such employees, directors, officers or agents of Rotaid AED Cabinets.
3. The promoter of the competition is Rotaid AED Cabinets, Keizersveld 52d, 5803 AN, Venray, The Netherlands
4. Participation in the competition consists out of:
 1. Placing the "Wir brauchen einen defi" poster on a building, structure, wall or premises;
 2. Taking a picture of the poster and its surroundings (context);
 3. Posting the picture, together with its location, on Facebook or Instagram using the hashtag #rotaid
 4. Gaining as much likes as possible on the post.

Participants can submit an unlimited amount of unique pictures during the competition. The competition does not allow to submit identical pictures.

It is crucial that the structure on which the poster is placed is visible for at least 50%.

5. The promoter will hold the entrant's personal information for the purposes of administering the competition and gather information in regard to the number of likes for each post. The winner will be contacted after June 1st to receive the price and make arrangements.
6. Entry images which are of poor quality, offensive or without context will not be accepted. Furthermore, entrants need to comply with specific laws and rules that may apply to a certain building, structure of premises and respect the owner's privacy. Rotaid AED Cabinets is in no way liable for breaching of possible laws, privacy and rules that may apply.
7. The prize will be allocated to the person in whose name the entry was made. The winner will be asked to nominate someone to travel with them and may be asked to provide documentary proof of their own and their nominee's name and address. The use of a false name or address by an entrant or nominee will disqualify them from winning.
8. The winner of the competition will be the entrant whose post has generated the largest number of likes on either Instagram or Facebook. The images must be tagged with #rotaid and the number of likes are defined on June 2nd.

9. The winner will be entitled to a prize of a double Hotel in room in Amsterdam's city center in a weekend of choice. Furthermore, a diner on arrival day for 2 persons is included in the prize. Travel costs and other expenses are not covered by the prize.

The winner can also opt for a € 350,00 voucher which they can use to acquire a defibrillator and or defibrillator cabinet. If the winner opts for this prize the hardware will be bought at a certified Rotaid AED Cabinets' distributor.

10. The winner agrees that personal information of the travelers is required to make the hotel and diner reservations and this information is provided to Rotaid AED Cabinets when asked to.

11. By entering the competition entrants are deemed to have agreed to the terms and conditions of the competition. Any breach of these terms & conditions, as determined exclusively by the promoter, will result in disqualification.

14. The promoter accepts no liability for any direct, indirect or consequential loss or damage arising from the promotion.

15. The winner may be required to take part in promotional activities and the promoter reserves the right to publish the entry, name, photograph and value of prizes paid to the winner.

16. The promoter reserves the right in its absolute discretion to disqualify any person from the competition, to add to, amend or waive any rule without prior notice to the entrant and, in the event of circumstances beyond its control, to cancel the competition at any stage.

17. This agreement is governed by the laws of Netherlands and subject to the non-exclusive jurisdiction of the Netherlands courts.

18. These terms and conditions do not affect any statutory rights you may have as a consumer.
